- (4) The stock options vest in three equal installments on February 11, 2012, February 11, 2013 and February 11, 2014.
- (5) Each performance-based restricted stock right represents a contingent right to receive one share of Ryder common stock based on the Company achieving a financial performance goal for the three-year performance period ending December 31, 2013. Performance-based restricted stock rights that do not vest will be cancelled.
